Information on processing of personal data in the interest of data protection, in accordance with Regulation of the European Parliament European Parliament and of the Council (EU) 2016/679 of 27 April 2016. On the protection of natural persons in relation to the processing of personal data personal data and on the free movement of such data data and repealing Directive 95/46/EC (General Data Protection Regulation on data protection), hereinafter referred to as RODO, AutoComfort is taking the steps described in this document.

We inform you herein how the data you have submitted is collected, processed, used and secured by our company.

1. The administrator of the personal data provided by you is AutoComfort Tomasz Gałązka Aleja Niepodległości 708/20, 81-853 Sopot

2. Your data may be processed for the following purposes:

- - concluding and performing the contract for transport and logistics services and
- ordering passenger transport services (art.6(1)(c) RODO),
- - verifying your reliability as our customer, including your ability to pay before entering into a contract on the basis of your consent (art.6(1)(a,b) RODO),
- - analytical (to better match services to customer needs) and the direct marketing of our and our partners, including the organisation of promotional events, conferences, organising and running competitions, sending promotional information by post, by means of electronic communication, including by electronic means including sms /mms, instant messaging or e-mail based on your consent (art.6(1)(c) RODO),
- - accounting and taxation due to our legal obligation to legal obligation to archive data (art.6(1)(c) RODO)
- - the possible assertion of civil law claims to which we are entitled and not civil law claims to which we are entitled and which have not been settled (in particular for late payment, if any), as well as in order to defend ourselves against possible claims from our customers and third parties, in pursuit of our legitimate interests (Art. legitimate interests (art.6(1)(f) RODO),st.1(c) RODO),
- - archiving (for evidential purposes), in pursuit of our legitimate interests (art. our legitimate interests (art.6(1)(c) RODO).

3. We may process the following categories of personal data: contact and identification data (e.g. name, TIN, customer number), biometric data, address data, data on ability to pay, details of the work performed and the position held, details of vehicles used (VIN, registration number, etc.)

4 AutoComfort envisages sharing personal data with the following categories of recipients:

- our partners with whom, jointly or with the help of whom we offer services to our customers,
- advertising agencies, law firms, our subcontractors, hotels and other training, conference and event organisers,
- postal operators, carriers, printers, associations, associations and professional organisations.

5 You have the right to access the content of your data: rectification (amendment) , erasure, restriction processing or to request data portability to another controller.

6. You have the right to withdraw your consent at any time by informing us processing by informing us by e-mail to firma@autocomfort.pl or by post to: aleja Niepodległości 708/20, 81-853 Sopot, by sending a statement of withdrawal of consent .

7. In the event that you discover a breach of your personal data (non-compliance of the processing with the RODO) you may lodge a complaint with the competent supervisory authority (PUODO) at any time

8. You also have the right to object at any time and free of charge to object to the processing of your personal data your personal data for direct marketing purposes.
